Qualitative analysis of Criterion 1

Shri R. K. Patil Arts, Commerce and Science College, Sankh, Sangli District, Maharashtra an Under-Graduate, linguistic minority, co-educational private college established in the year 2018 as an academic branch of 'Shivlingeshwar Shikshan Sanstha' is affiliated with the Shivaji University, Kolhapur. The Institution offers 03 UG Program (B.A.; B.Com.; B.Sc.) with CBCS/NEP pattern of curriculum. However, the institution has introduced one UG programme(BCA) and one PG programme(Chemistry) in the year 2023-24 session. The curriculum designed by the parent university is implemented and monitored. Effective implementation of the curriculum is executed using the processes such as the preparation of academic calendar & timetable. As a part of the curricular enrichment and academic flexibility 20 different addon/certificate/value-added program, each of 30 hours duration were conducted, benefitting more than 1109 students during the last 05 years. The curriculum provides special lectures, seminars / workshops, field trips, to enhance the learning competency of the students. The college has adopted semester pattern of examination and Continuous Internal Evaluation System designed to assess the program outcomes (POs) and Course outcomes (COs) from time to time. The institution integrates cross-cutting issues relevant to professional ethics, gender equity, human values, human rights, social work, environment and sustainability into the curriculum. The curricular aspect has also been further strengthened by activities such as project work / field work/seminars / workshops, invited lecture, etc. to enhance the learning competencies of the students. Structured feedbacks on the design of the syllabus collected from teachers and students of the college are analyzed, then the action taken reports are uploaded on the college website

The student admission process is transparent and made through on-line portal. The institution enhances the learning experience of the students by adopting various student-centric methods such as experiential learning, participative learning, and problem solving methodologies by conducting different activities such as group discussions, study tours, field visits, seminars/ workshops, project work, extra-curricular activities for the students. The institution prepares the academic calendar with detailed list of program, days and important academic events. The departmental time table and course distribution are usually finalized at the beginning of each semester. The college adopts Continuous Internal Evaluation(CIE) system and semester pattern of examination. The students are aware of the examination pattern at the beginning of the session. The evaluation process is adequately monitored. Modes of examination and evaluation processes are uploaded in the college website . The evaluation method has two significant components, i.e., continuous internal assessment and End semester external assessment with weightage of 20% and 80% respectively. Continuous internal assessment is based on the performance in a periodical unit test, field work, group discussions, viva etc. The examinations of 1st and 2nd year are conducted and evaluated at the institutional level. However, the third and final year examinations are conducted by the affiliating Shivaji University, Kolhapur. through off-line mode. Provision of revaluation of answer scripts exists. The mechanism of internal/external assessment is transparent and grievance redressal system is time bound and efficient . Course outcomes (COs) and Program outcomes(POs) are made available on the college website for the information of all stakeholders. Since 2022-23 session, the attainment of POs and COs are discussed and evaluated by the respective department/ institution at the end of each semester to monitor the learning levels and identify gaps in learning outcomes. Program outcomes and Course outcomes are also communicated to the students through website.

The research activities in the institution is limited. Only two of the faculty has Ph.D degree and the number of research publications during the last five years is 04. However, the institutional policy to encourage the faculties to participate in the seminars, conferences, workshops exists. The institution has organized 02 one day seminars in the last 05 years. The institution's extension activities are seen in its efforts to reach the neighborhood community. About forty extension/ outreach activities and two seven day community service camps are conducted by the college during last 05 years. Such activities as environmental awareness, voters' awareness program, Legal Awareness, AIDS Awareness Program, Har Ghar Triranga rally . are some of the initiatives undertaken by the college. Blood donation camp and various other activities are also conducted through the NSS volunteers of the college. Under the "*Swachh Bharat* Mission," the students are encouraged to participate in campus cleaning and neighborhood clearing programmes. For such service-oriented activities the teachers and students of the college, has got appreciation from the neighborhood community. The college has signed 05 MOUs with different institutions for collaborative activities

The institution has two double storied building blocks, one main building and another block containing classrooms and library. hostels for boys, toilet blocks with a built-up area of 6224 Sq.mts. spread over 07 Acres of land of its own. The entire college is under the surveillance of 32 CCTV cameras installed in different strategic locations of the institution. The vending machine is available in ladies wash room. The College has 10 well ventilated classrooms, 01 classroom fitted with LCD, 7 laboratories including one computer lab for BCA(with 18 systems having 100 mbps internet speed) with required facilities, 05 printers, 04 scanner, 03 LCD projector and 02 xerox machines . Other facilities available include: separate rooms for principal's cabin, IQAC, administrative Office., examination centre with SRPD facility, staff room, girl's common room, Yoga center and facility of clean drinking water (RO water), canteen, parking shed. They have also initiated green practices like rainwater collecting system, botanical garden, vermi-composting unit, bee keeping, plastic collection shed, and drip irrigation. Suggestion Box is available in the College's main building. Ramps, wheel chairs , walker, and toilet facilities are also available in the college for Divyangian. The college has facilities for both Indoor and Outdoor games. A separate indoor stadium of 7800 sqft is under construction. An Outdoor sports ground covering an area of 1.73 acres contains facilities for conducting various games/sports such as :football, volley ball, kho-kho, kabaddi, cricket, and athletics in the campus. The musical instruments such as Dholki, Tabala, Dimdya, Harmonium etc. are available in the college. Noted cultural activities include : Rangoli, dance, music, cultural fashions how, painting etc. The institution has incurred an expenditure of 166.5 lakhs for infrastructure development and augmentation in the last 05 years. The College Library contains 2000+ books, one computer with internet access and one printer along with a reading room of 20 students sitting capacity. The institution provides IT facilities for teaching- learning, administrative, examination and student admission processes. College has 32 computers with two broadband connections of 100 MBPS bandwidth. All the computers are equipped with necessary software and anti virus protection .The surveillance of the campus security is maintained through 32 CCTV cameras installed in different strategic locations of the college. The college has properly maintained laboratories for all science

departments. Registers are maintained, and the Internal Stock Verification is done by the respective departmental committee. Equipments are maintained under the supervision of the respective HoDs and staff members. The college authority purchases laboratory equipment through an established system. The college library is maintained by the library staff and monitored through Gate Entry. Physical stock verification and sports equipment maintenance are done annually. The College Development Council is responsible for the maintenance of class rooms and laboratories. The institution has incurred an expenditure of Rs. 18.32 Lakhs on the physical and academic maintenance of the college during the last 05 years. This has been duly audited by CA.

Qualitative analysis of Criterion 5

The institution conducts various activities towards capacity building and skill development of the students. The college facilitates for central and state government scholarships and other eligible scholarships benefiting 800 students in the last 05 years. The institution has conducted 20 different add-on /certificate / value added courses benefitting 1109 students in the last 05 years .The college Grievance Redressal committee, under the chairmanship of the Principal, addresses the complaints of the students related to various issues and takes measures wherever needed. There is no formal student council. However, nominated student representatives have representation in IQAC and some other college committees. Student volunteers of the NSS play significant roles in maintaining a clean and solid waste free campus. Regarding student progression of the institution , around68 (5.2 %) outgoing students have got placement and progressed for higher studies in the last 05 years . 03 students have qualified in the State Govt. examinations in the last 05 years. Around 277 Students have participated in various sports/cultural activities at the college and university level and out of them only 02 student was awarded at the University level for their outstanding performance in athletics during this assessment period. The Alumni Association is registered recently. Their suggestions and recommendations are honored in updating the academic and other co-curricular activities. The alumni has donated one printer for college office and notebooks for the usage of students.

The institutional governance and leadership are in accordance with the vision and mission of the institution and it is visible in its various institutional practices such as sustained institutional growth, decentralization and participative management in the institutional governance .The institution's administration rests on the governing body which decides the policies and their implementation. However, the day to day administration, academics and functioning of the college rest with the principal, whose effective leadership works with the support of teaching and non-teaching members, HODs and members of various committees / cells contribute for the institution growth and development. The involvement of faculties at different levels of the college, administration has created a participatory management. The institution implements the practice of egovernance in the areas of Administration, Student Admission and Examination. The strategies for external resource mobilization are limited. Funds are mainly collected from the student in the form of tuition fee, Term end examination fees, fee from self-financing courses, Government scholarships, and the Management grant contributed by the Sanstha (SSA). During the last 05 years the institution has incurred an expenditure of 194.3 Lakhs which it has received from the sources as mentioned above. At the end of every financial year, the account and financial statements are audited internally by the Management committee and externally by Charted Accountant. The appointment of the faculty members are made by the management committee following the procedure as specified by the Shivaji University, Kolhapur and the Government of Maharashtra . Some of the staff welfare measures include : Casual leave, Maternity leave, duty leave to attend FDP / MDP program, and financial support to attend conferences / seminars / workshops . During this assessment period, 04 members of the teaching staff have participated in the seminar/ workshop and 22 of the teaching staff and 34 non-teaching staff have participated in the FDP/ administrative training program...The employees of the college are provided with free uniform every year. IQAC prepares the academic calendar, plans and strategies of various academic ,co-curricular, and extracurricular activities of the institution, by

organizing guest lectures, gender and women awareness program, workshops for quality enhancement etc. . It has initiated institutional academic audit for 2022- 23 session by the parent university . The peer review-based audit is followed in teaching-learning activities and laboratory management. IQAC has conducted green audit and taken steps in the initiation and implementation of 05 MOUs with the respective agencies , The IQAC has implemented online collection of feedback from students and faculty based on institutional parameters such as infrastructure and facilities, curriculum contents, discipline aspects, environment, staff and support and keeps all important records. Qualitative analysis of Criterion 7

The students hail from different places in and around Sankh and are of diverse socio-economic, cultural, linguistic and academic backgrounds. The institution provides educational opportunities for rural, drought prone and poverty stricken youth. Solid wastes such as Paper, Plastics, glass, metals, foods and vegetables are collected regularly from the campus and steps were taken for their proper disposal. Food wastes are dumped in separate pits for decomposing. NSS, and student volunteers take part in the waste management of the college. As the part of green campus initiatives the institution has undertaken plantation work and uses LED lights in the campus .They have also initiated green practices like rainwater collecting system, botanical garden, vermi-composting unit ,bee keeping ,plastic collection shed, and drip irrigation. Provisions were also made for providing water for birds on hanging pots during dry seasons.. The institution has conducted green audit for 2022-23 and energy audit for 2021-22 and environment audit 2022-23 session under the guidance of IQAC. The institution has barrier-free environment with the provision of ramps for easy access of Divyangjan to classrooms as well as to the washrooms. In addition wheel chair is also made available for use in the campus. The college provides an inclusive environment for all stakeholders with tolerance and harmony towards cultural, regional, linguistic, communal, socio-economic and other diversities. By embracing inclusivity and accessibility the institution fosters an environment that promotes equal opportunities and respects the diverse needs of all its members. The linkage between the students and the

community is initiated through the NSS by conducting camps in nearby villages. The institution gives equal importance to academics, sports and extension activities so that all the students get holistic education. Program such as Environmental Studies, Value Education, and Soft skills are meant for the holistic development of the students. The college organizes various activities on the birthdays and the death anniversaries of national heroes to make the students aware of their contributions to building the nation .Events and festivals celebrated in the college during the last five years are- Independence Day, Republic Day, Gandhi Jayanthi, Hindi Diwas, Vivekananda Jayanti, Savitribai Phule birth anniversary, International women's Day, Chatrapati Shivaji Maharaj birth day World Environment Day, International Women's day, International Yoga Day, etc. . The institution has adopted two best practices i.e. 'Improve your English 'and 'Cleanliness drive in College Campus ' . The 1st best practice initiatives to improve the English vocabulary of the students. The 2nd one indicates the institutional concern for an eco friendly campus , under which, plantation of saplings were made in the campus to develop greenery all around the area . In addition steps are also being taken for the collection and disposable of the solid wastes and conduct green audit for environment sustainability.

- Effective e-governance in the areas of college administration,, finance and accounts need to be implemented.
